

#### Register your Company to Conduct Business with the Government

Each year, local, state and federal governments purchase more than \$300 billion from small businesses. From routine office supplies, service contractors and replacement parts for military aircraft, Uncle Sam offers potentially lucrative, yet largely untapped markets for many companies. Knowing how the government acquisition system works and finding out who in the government buys your products and services can be a challenge. The Illinois Procurement Technical Assistance Center at Black Hawk College was established in our region to help you overcome those challenges and learn how to do business with the government. As a PTAC client, you receive technical assistance and services which include:

- Electronic Bid Match/Bid Award We'll notify you by e-mail about bidding opportunities and bid awards that are retrieved from over 400 databases nation-wide.
- **Bid Preparation** We'll help you prepare for the offer and work with you to exceed bid specifications and quality requirements.
- Registration We'll help you identify which governmental agencies are likely to buy your products and services and assist you in registering with them.
- **Certification** If applicable, we'll help you apply for special certification programs that can increase the likelihood of winning contracts with certain agencies.
- Research Assistance We'll conduct research on competitors and provide access to governmental contracting manuals.
- Workshops/Seminars Periodic programs on topics related to effective government contracting, business matchmaking services and navigating government regulations. There is a small fee for workshops/seminars.

Participation in the Bureau of Prisons (BOP) acquisition process is the same as with any other federal agency in accordance with procedures stated in the Federal Acquisition Streamlining Act (FASA) of 1994. All federal agencies are required to post notices of proposed government purchases exceeding \$25,000, sub-contracting leads, contract awards, sales of surplus property and foreign business opportunities to the government electronic point of entry systems know as the Federal Business Opportunities (FBO), at <a href="www.fedbizopps.gov">www.fedbizopps.gov</a>. Since the use of this website is mandatory for all federal agencies, it is the most comprehensive and effective method of receiving solicitations. Companies wishing to do business with the BOP are strongly encouraged to become familiar with the FBO and to register for notifications of solicitations in their area of expertise.

Federal regulations mandate that purchases less than \$100,000 are set aside for small business except those under \$2,499, which could be made at a small or large business, using a government issued purchase card. Purchases over \$2,500 will be completed by the institution Contracting Officer after checking GSA mandatory sources such as Small Disadvantaged Business Program, 8(a) firms and HUBZone certified companies.

**Examples of products include:** perishable food items, fresh eggs and dairy products, fresh produce, bread and bakery items, recreational equipment, kosher food products, lumber, tools, canned goods, office supplies but NOT computer items.

**Examples of Services include:** comprehensive medical services, parenting/substance abuse services, water and sewer services, solid waste collection and recycling services, spiritual services, vocational instructors services, ambulance and burial services, medical material waste services, food service and office equipment maintenance services.

#### Prepare for Partnership NOW

Register your company to conduct business with federal agencies:

- Be prepared to do business—be established, have a written business plan and be in good standing with your credit, bank, and vendors
- Get a Federal Employers Identification Number (FEIN) or as many call it your tax number. This can be obtained from the Internal Revenue Service (IRS) at <a href="https://www.irs.gov">www.irs.gov</a>
- Get registered with the Central Contractor Registration (CCR.gov) database
- Contact the General Service Administration (GSA) at 703-305-6566 to find the purchasing schedule and other vital information
- Identify if your company is within a special contract incentive area that the Federal Government targets for special contracting incentives:
- 8 (a) Registration (socially or economically disadvantaged company)
- HUB Zone Registration (located in geographical historically underutilized business zones)
- Small Disadvantage Business Program (SDB)
- Veterans Employment Registration
- Be able to accept credit card purchases. Government agencies do have credit cards! In fact, in some cases purchases under \$2,499 may require to be purchased on credit cards
- 7. Call 800-705-5711 to get your DUNS number.
- Be able to accept and send Electronic Funds Transfer (EFT) payments. This is something that your banking professional can help you with.

The U.S. Census Bureau conducts an economic census every five years, as mandated by Title 13, U.S. Code. In late 2012, nearly 5 million businesses will receive 2012 Economic Census forms. All large and mid-size businesses will receive forms as well as a sample of the smallest establishments. Businesses will have the option to report on paper or electronically. Information is collected about virtually every U.S. business and summarizes data for each industry and geographic area to publish a complete and accurate portrait of the American economy. Federal law guarantees the confidentiality of information you provide on your census form.

The 2012 Economic Census
YOUR RESPONSE
MAKES A DIFFERENCE

Census publications contain only aggregated statistics that combine information from many businesses. They do not identify individual businesses or their operations, and they are carefully reviewed to prevent unintended disclosure. The Economic Census is important because it

produces comprehensive "snapshots" of our economy and our most widely used business statistics. Census statistics feature economy-wide coverage, exceptional accuracy, encyclopedic detail, and historic comparability. These data are used in private sector business plans, public policy development, and statistical program quality control. Federal law requires you to complete your Economic Census form and return it to the Census Bureau. The forms are due by February 12, 2013. 
